Our Promise

Thank you for choosing EZFIT.

We recognize that purchasing a storage building or outdoor structure is an investment in your property. Every structure we build reflects our commitment to quality craftsmanship, dependable materials, and exceptional customer service.

We stand behind our workmanship and are committed to correcting defects in materials or manufacturing that are covered under this Limited Conditional Warranty. With proper care and routine maintenance, your EZFIT shed is designed to provide many years of dependable service.

This warranty explains what is covered, what is not covered, and the responsibilities of both EZFIT and the owner. Please retain this document with your purchase records for future reference. We sincerely appreciate your business and thank you for placing your trust in EZFIT.

Warranty Coverage

EZFIT warrants to the Original Purchaser that the structural components of the Product shall be free from defects in workmanship for ten (10) years from the Delivery Date. Accessories, hardware, cupolas and metal components are warranted for two (2) years from the Delivery Date.

Scope of Coverage

This warranty covers structural strength, materials, and manufacturing defects that materially impair the intended use of the Product. EZFIT may, at its sole discretion, repair, replace, or reimburse the reasonable value of the defective component.

Owner Requirements

Your shed kit must be painted within sixty (60) days of assembly using 100% acrylic latex exterior paint and reasonably maintained thereafter. The owner must keep vegetation, debris, and standing water away from the structure, and prevent sprinkler spray from contacting the building. The minimum ground clearance for wood siding must be (1/4") from concrete slab or (2 1/2") from the ground when constructed on a wooden floor. Buildings must be caulked above all doors and windows. Shed kit must be erected in accordance with the assembly instructions, within 1 year of receiving delivery. A shingle or metal roof must be properly installed. Customer is required to check the quality and completeness of the product as soon as possible after receipt of it, before beginning the assembly process.

Warranty Exclusions

This warranty does not cover re-leveling due to settling; Other exclusions are improper site preparation; natural cracking, shrinking, splitting, or warping of wood; damage caused by fire, flood, hail, wind, insects, vandalism, theft, earthquakes, hurricanes, or other Acts of God; normal wear and tear; neglect; abuse; unauthorized modifications; or moving of the structure after assembly. Fading, color change and color match are excluded under this warranty. Due to sun exposure and the elements, all colors may fade to some degree. This warranty excludes improper assembly.

Non-Transferable Warranty

This warranty is non-transferable; it is only valid to the original purchaser of the product.

Warranty Claims

To initiate a claim, contact our parent company, Alpine Structures LLC at 330-359-5708 or sales@ezfitsheds.com. Provide your name, address, telephone number, product information, photographs if requested, and the original invoice number if available. Claims for original defects in workmanship shall be made to EZFIT no later than ten (10) days after the expiration of the warranty period.

Limitation of Liability

EZFIT makes no warranties other than those which are specifically described herein. EZFIT makes no implied warranty of merchantability or implied warranty of fitness for a particular purpose. Some states do not allow limitations of implied warranty so this limitation may not apply to you. In that event, any such implied warranty is limited to that required by law. EZFIT shall not be liable for incidental, indirect, punitive, or consequential damages, including, but not limited to, lost profits or other economic or commercial losses. The sole remedy provided in this warranty is repair or replacement of this product. EZFIT's warranty does not cover materials or component parts; however, EZFIT's warranty shall not limit any warranties made by manufacturers of materials or component parts which may extend to you. Ask for a complete list of applicable manufacturer's warranties.

Ohio Governing Law

This warranty shall be governed by and construed in accordance with the laws of the State of Ohio. Any unenforceable provision shall be severed without affecting the remainder of the Warranty.
